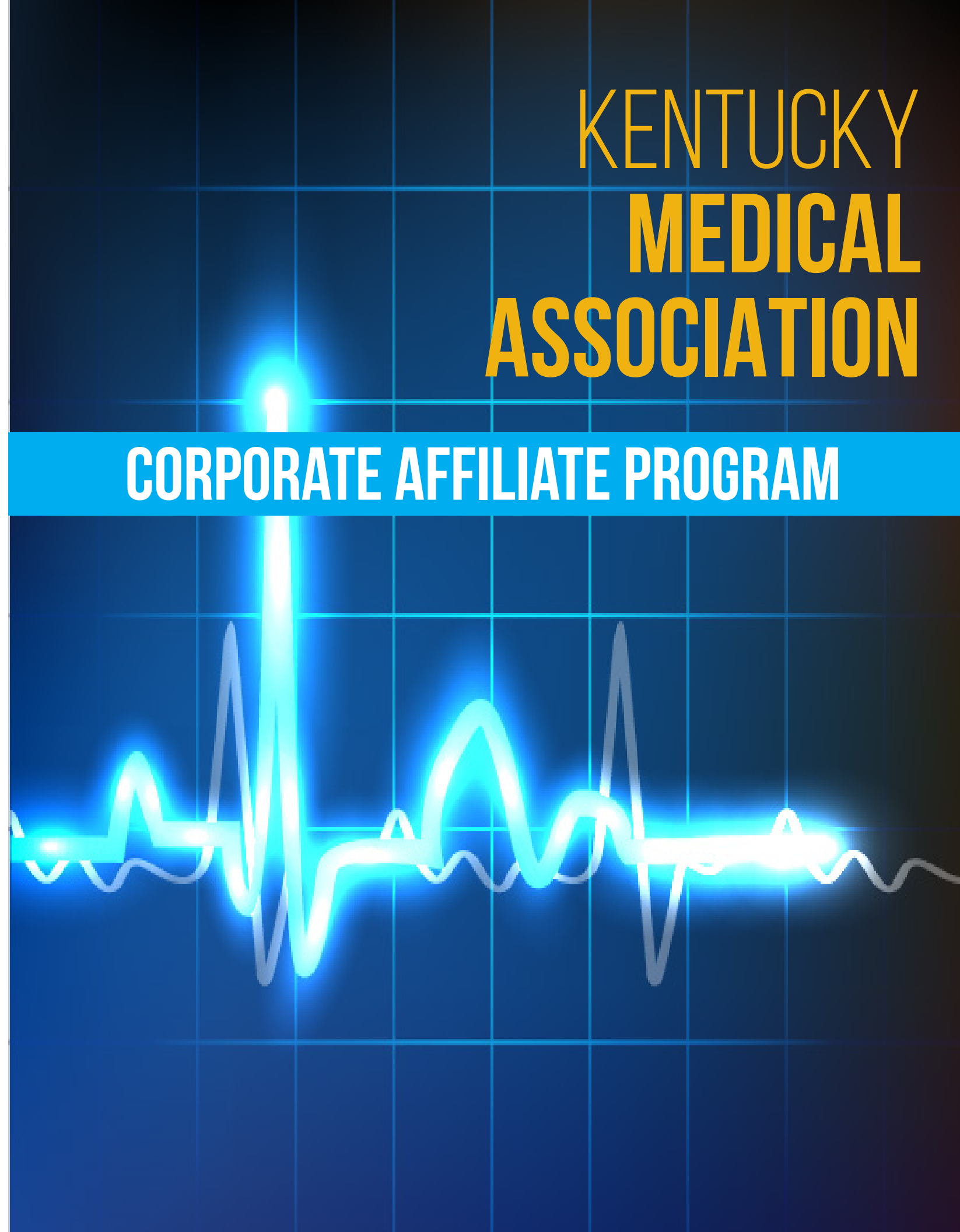

KMA CORPORATE AFFILIATES
