TRAINING UPDATES

KY MPPA training opportunities will be available very soon. Watch future issues of this newsletter, and the [KY MPPA website](#) for dates and times of upcoming training webinars.

TOP HEADLINES

- Kentucky Medicaid Partner Portal Application (KY MPPA) is a web-based application that streamlines the process of applying to become a new Medicaid Service Provider.
- KY MPPA was created for Individuals, Groups, and Entities applying for a KY Medicaid ID. KY MPPA allows current Medicaid providers to perform maintenance, revalidation, and change of ownership online.
- Department for Medicaid Services (DMS) began using KY MPPA in August 2017, and in January 2018, KY MPPA launched its first pilot program with a selection of five large hospitals. KY MPPA will soon begin another pilot phase, and will be adding provider types to this pilot very soon.
- The new pilot will include the following provider types and one or more medium-sized hospitals: Chiropractor (85), Dentist (60), Licensed Clinical Social Worker (82), Licensed Professional Clinical Counselor (81), Occupational Therapist (88), Optometrist (77), Physical Therapist (87), Speech Language Pathologist (79).
- DMS has partnered with TACs, licensing boards, and professional associations to assist with KY MPPA communications, and the onboarding of Providers.

FREQUENTLY ASKED QUESTIONS

Why move from paper applications to an online portal?

Manual paper applications have a long history. However, they take time to complete, can be confusing, and errors submitted on paper applications take time and effort to be identified– delaying the application process. KY MPPA's online portal is faster and easier to use, identifies many common errors prior to submission, and allows for faster application approvals.

Why should I use KY MPPA?

KY MPPA will reduce the amount of time required of providers and credentialing agents to complete and review applications, freeing up more time to devote to patients and clients.

How do I sign up to use KY MPPA?

Accessing KY MPPA is a four-step process:

- Register with the Kentucky Online Gateway (KOG)
- Perform security validations for KOG and KY MPPA
- Access your KY MPPA account
- For existing Medicaid Providers: Link to your existing Medicaid IDs

How do I register for a KOG account?
